Further to the Annual General Meeting of Augur Resources Ltd ('Augur') held on 29 November 2013, Augur has, following receipt of the payment by the Rajawali Group of subscription consideration of \$3,000,000, issued 60,000,000 new fully paid ordinary shares to Rajawali's nominee, PT. Archi Indonesia ('PT Archi'). In addition, Augur has granted to PT Archi the option to subscribe for a further 50,536,400 fully paid ordinary shares for \$3,750,000 as approved by shareholders at the Annual General Meeting.
