HPA PILOT PLANT UPDATE

- HPA refining process well advanced
- 56kg of HPA pre-cursor has now been refined and HPA calcining commenced

Alpha HPA Limited ('Alpha' or 'the Company') is pleased to provide an update on its HPA First Pilot Plant operations in Brisbane.

The high purity alumina (HPA) refining campaign (2B), being the conversion of Al-salt to HPA pre-cursor and then to HPA commenced on 12 August 2019. To date, 56kg of HPA pre-cursor has been produced from multiple batches, representing approximately 50% of the Al- salt.

The HPA pre-cursor is now being progressively calcined into a final HPA product through the Company's static calciner in Brisbane with several kilograms expected to be produced over the coming weeks. To advance the calcination rate, and to collect key thermal heat-up and cool-down data, the Company has ordered a lab-scale rotary calciner for installation in September.

Next Steps

The first batches of HPA have now been despatched to a high-purity lab in the USA for assaying and specialist jet milling and from there will be distributed to offtake parties for qualification testwork. First assay results from the high purity lab are expected next week.

About the HPA First Project

The Company's HPA First Project represents the evaluation and intended commercialisation of the production of ~10,000tpa of high purity alumina (HPA) using the Company's proprietary licenced solvent extraction and HPA refining technology. The technology provides for the extraction and purification of aluminium from an industrial feedstock to produce 4N (>99.99% purity) alumina for the intended use within the lithium ion battery and LED lighting industry. Following a successful testwork programme and Pre-Feasibility Study (PFS), updated in March 2019, Alpha HPA is now completing a pilot plant program at its dedicated laboratory facility in Brisbane, as part of a full definitive Feasibility Study (DFS) due for delivery in CY2019.

Key highlights of the PFS (ASX: 7 March 2019):

- Unit production costs of **US\$5,123** per tonne of HPA (after by-product credits)
- Annual Free Cash Flow (FCF) at full production rate, of US\$199 million (assuming US\$25,000/t HPA)
- Capital Expenditure of US\$149 million
